2016 Sources of Available Credit

- Approximately \$14.6 million of competitive credit was available in the 2016 LIHTC cycle
 - Through the competitive scoring process, WHEDA incents developers to maximize financial participation and credit usage points. This creates a condition where developments request less LIHTC than they would be entitled to by the eligible basis calculation. The amount of LIHTC leverage created through this mechanism was an additional \$3,283,034 or 23%.

- 39 applications were submitted for developments in 22 Wisconsin communities, including:
 - Milwaukee (12)
 - Madison (5)
 - Fond du Lac (2)
 - Superior (2)



2016 LIHTC Awards

- On May 2, LIHTC awards were made to properties in 15 Wisconsin communities, including Milwaukee (9), Madison (5), and Fond du Lac (2)
- The 28 LIHTC awards will assist in the development or rehabilitation of 1,307 residential units including 1,166 affordable units
- The 28 projects represent more than \$250 million of construction, rehabilitation and related soft costs

2016 LIHTC Scoring Results

Scoring Summary

- Scoring Categories: 17
- Maximum Score: 409
- Minimum Eligible Score: 130
- Average Scores
 - All Applications: 275
 - Applications Receiving Awards: 301
 - Applications Not Receiving Awards: 210



Differences: Those that Did, or Didn't Receive an Award

- The average application receiving an LIHTC award scored 91 more points than the average application that didn't receive an award.
 - Note: The 91 point difference is skewed by the number of non-awardees from the preservation set-aside was 7 of the total non-awardees of 11. The preservation set-aside projects typically score about 40% lower than the other set-aside projects.
- Categories in which awarded applications scored noticeably more points:
 - Serves Lowest-Income Residents (+39.1 points)
 - Financial Participation (+12.6 points)
 - Credit Usage (+11.5 points)
 - Employment Centers & High Need Areas (8.8 points)



Differences: Those that Did, or Didn't Receive an Award (Continued)

- WHEDA restricts certain projects from being able to score in certain point categories for the following:
 - Applying in the Preservation Set-Aside
 - Applying in the Supportive Housing Set-Aside
 - Maintaining federal operating subsidies
 - Scoring points in other point categories
- Other times applicants opt to not claim points in certain categories independently. These circumstances can skew the scoring category point averages. When these circumstances are removed from the analysis these are the categories in which awarded applications scored noticeably more points that non-awarded applications:
 - Credit Usage (+10.6 points)
 - Financial Participation (+9.5 points)
